A Hong Kong or Macau Passport valid for more than 6 months should be presented to the immigration officer for inspection at both arrival and departure. 4. This permit is required to be printed in A4 format on an A4 size blank white paper. 5. This online application is not applicable for holders of foreign passport, except for HK resident with BNO passport or Macau resident with Portuguese passport issued before 1999.
